

#### 2. Evolution of National Committees in 2017

Significant variations.

In 2017 there have been significant variations in the number of members in some countries with increases in India, Turkey, Iran, Chile, Hungary and decreases in GCC and Egypt.

The ranking is based on Equivalent membership

In 2017 the 10 largest NCs were: China, Brazil, Japan, the United States, Russia, India, Germany, the United Kingdom, Australia and France.

- 2 new NCs have been created: Colombia and Kosovo.
- 2 NCs in difficulties since 2013 have been suspended: Libya and Venezuela.

#### 3. National Committees below 40 equivalent Members (statutory requirement)

In 2017 only 3 NCs had less than the requested 40 Equivalent Members:

Indonesia [26] - Cyprus [30] - Estonia [35]

Whereas in 2016, 7 NCs had less than 40 Equivalent Members:
 Libya [0] - Venezuela [01] - Hungary [15] - Indonesia [16] - Cyprus [30] - Estonia [34] - Mexico [36].

#### 4. Transfer of the membership fees

 Renewal membership fees of the current year must be transferred to the Central Office on March 31, at the latest. It is a mandatory deadline date.

#### Important note:

Nearly 50% of the National Committees did not comply with this requirement - neither in 2016 nor in 2017.

Membership fees of new members must be transferred before December 15 of the current year.
 (for administrative reasons)
